**<u>1-year Shell (body) exterior warranty covers</u>**. Ball Coupler, Cargo Ramp, Entry Door, Hand Jack, Safety Chain & Hooks, Aluminum Sheeting, Fiberglass Roofing; Axle (s); Wheel-End components (Bearings, Brake Drums, Idler Hubs, Spindles)
